Requesting a Driver's Abstract from Out of Province

Step 1: Fill out the attached form

Step 2: Have the completed form **AND** a photocopy of your Identification that contains your photo, legal name, and date of birth (Driver's License, Passport, Citizenship Card, Permanent Resident Card, etc.)

Step 3: Submit all notarized pages and fees (Cheque, Money Order, Visa, or Mastercard) by mail, registered mail, or courier to:

The notarized forms **MUST** be received within one month from the date the documents were notarized. Once received the abstract will be returned to you by courier or registered mail.
